Thanks for getting me the video link.

Sounds like you are heading down the same path that we did (drawings, settings, and so forth). I believe that a copy of a report of ours was given to Dr. Putterman describing some of our work here.? That report was originally going to be submitted to NURETH-11 with a null result, however it was decided not to publish. Because the report was intended to be made public, there were many details missing.

Xu, Butt, and Revankar presented a paper at NURETH-11 last week, however it was mostly like the one in NED. Xu is Taleyarkhan's post-doc and Butt is one of his Master's students. Neither Xu nor Butt worked on the project prior to Taleyarkhan arriving at Purdue.

My colleague, Anton Bougaev, and I performed most of the physical work that was undertaken here prior to Rusi's arrival. We are both interested in talking further with you. If you are interested, it would not be a problem for us to drive to UIUC to discuss this.

## Hi, Josh.

I presume you're referring to the paper by Yiban Xua and Adam Butt (was there more than one paper!?). I've been very curious about that paper and how independent it truly was of Taleyarkhan, and you seem to know more about it than I've been able to get from Rusi. You've certainly got my curiosity picqued!

Currently, I have a student from my labs out working at UCLA with Seth Putterman and his group trying to reproduce Taleyarkhan's experiment quite precisely. DARPA gave a chunk of money to Seth, myself, and especially Rusi to independently verify Rusi's results. As part of this, Rusi had to reveal very precise details of his experiment (including the cell design engineering drawings). That work is ongoing, but so far, no neutrons have been detected.
